**Wilkes University has amended the PPO Plans, the self-insured health insurance plans, effective June 1, 2016. Accordingly, certain provisions in your PPO Group Health Insurance Summary Plan Descriptions (SPDs) have been modified to describe and explain the PPO Plans as amended. The SMM should be maintained and read with the SPDs.**

The following description adds to or replaces the information in the Plan Documents as indicated:

**PLAN NAMES**

BlueCare PPO \$300 Deductible is changed to PPO Blue \$400 Deductible  
Blue Care PPO \$1,000 Deductible is changed to PPO Blue \$1,000 Deductible

**GROUP NUMBERS**

PPO Blue \$400 Deductible Group nos. 051316000, 051316099 are changed to 10213308, 10213309  
PPO Blue \$1000 Deductible Group nos. 051317000, 051317099 are changed to 10213310, 10213311

**SCHEDULE OF BENEFITS**

Third party administrator is Highmark Blue Cross Blue Shield

**ANNUAL LIMITATIONS**

The annual limitation on in-network out-of-pocket maximums increases to \$6,850 for self-only coverage and \$13,700 for family.

**DEDUCTIBLES/COPAYS (PPO BLUE \$400 DEDUCTIBLE PLAN)**

Medical Deductible: \$300 individual / \$900 family to \$400 individual / \$1,200 family In-Network  
\$600 individual / \$1,800 family to \$800 individual / \$2,400 family Out-

Network

Prescription Deductible: \$100 per person deductible

Office Visit: Primary Care Physician (PCP) \$20 copay to \$25 copay

Office Visit: Specialist \$40 copay to \$50 copay

Urgent Care: \$40 copay to \$50 copay

**PHARMACY BENEFITS – Specialty Medications**


Walgreens Specialty Pharmacy, LCC (1-888-347-3416) will be utilized to assist in the management of select specialty medications.

**EXCLUSIONS**

- The exclusion regarding dental procedures and oral surgery is updated to include an exception for coverage of orthognathic surgery for the treatment of obstructive sleep apnea.

All other terms and conditions of the Plan which are not affected by this Amendment are unchanged.
