This is a summary of the annual report for the Shared Services Health Plan, (Employer Identification No. 25-1882792, Plan No. 501) for the period July 1, 2022 to June 30, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

INSURANCE INFORMATION

The plan has contracts with Everest Reinsurance Company to pay certain medical, vision, and stop loss claims incurred under the terms of the plan.

The total premiums paid for the plan year beginning July 1, 2022 and ending June 30, 2023 were \$4.252.482.

The value of plan assets, after subtracting liabilities of the plan, was \$18,005,649 as of June 30, 2023 compare to \$17,747,697 as of July 1, 2022. During the plan year the plan experienced an increase in its assets of \$257,952. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$49,660,224. This income included employer contributions of \$34,199,967, employee contributions of \$9,018,119 and earnings from investments of \$11,907. Plan expenses were \$49,402,272. These expenses included \$1,563,058 in administrative expenses and \$47,839,214 in benefits paid to participants and beneficiaries.
