# **Summary Annual Report**

### Shared Services Health Plan

This is a summary of the annual report for the Shared Services Health Plan, (Employer Identification No. 25-1882792, Plan No. 501) for the period July 1, 2023 to June 30, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## **INSURANCE INFORMATION**

The plan has contracts with Everest Reinsurance Company to pay certain medical, vision, and stop loss claims incurred under the terms of the plan.

The total premiums paid for the plan year beginning July 1, 2023 and ending June 30, 2024 were \$5,112,725.

The value of plan assets, after subtracting liabilities of the plan, was \$15,834,168 as of June 30, 2024 compare to \$18,005,649 as of July 1, 2023. During the plan year the plan experienced a decrease in its net assets of \$2,171,481. This decrease includes unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$57,354,656. This income included employer contributions of \$36,721,232, employee contributions of \$9,319,573 and earnings from investments of \$475,328. Plan expenses were \$59,526,137. These expenses included \$1,711,208 in administrative expenses and \$57,814,929 in benefits paid to participants and beneficiaries.
